"It is certified that under Uttarakhand Government's Order No. 14/XXIV-C-2/2022/3 (Announcement) 2021 dated 04.01.2022 and under the announcement of the Honorable Chief Minister, tablets were to be provided to the government college students by 2022. Under this scheme in the financial year 2021-22, (1,26,00,00,000) one billion twenty-six crore rupees were released in the revenue side grant number 07, account title 2245-80-800-02, to the Department of Higher Education, which is related to the assistance scheme for Covid disaster, under number 42 other departmental expenditure items. Hon. Governor gladly approved the amount of money to be disbursed to the Director of Higher Education Department and also approved for the expenditure of 105 Govt. Degree Colleges of Uttarakhand. As per the scheme, in the order of the government's allocation letter number degree budget/5642-46/2021-22 dated 6 January 2022 for Rajkiya Mahavidyalaya, Amori (Champawat), Rs. 25,56,000 was released for the distribution of mobile tablets for college students into No-42, account head 4245 under the Honorable Chief Minister Tablet Scheme.

Under this scheme, 211 students of the college in the session 2021-22, as per 12000 of each student's DBT have been successfully made into their bank accounts under the Honorable Chief Minister Tablet Scheme. Thus, Rs 25 lakh 32 thousand were distributed in the college under this scheme." Also certified that 211 students of the college have purchased mobile tablets which has been verified by the college Mobile tablet Cell.

By 2022, under the Honorable Chief Minister's Announcement No. 423/2021 "Tablets will be made available to the students of Government Degree Colleges", under the Higher Education Department, in the financial year 2021-22, the revenue side's grant no. 07, account title 2245-80-800-02-COVID. Shri Governor happily approved the expenditure of ₹ 1,26,00,00,000/- (₹ One Billion Twenty Six Crore only) under 42-other departmental expenditure item of the Disaster Assistance Scheme under the disposal of the Director, Higher Education. Approval has been given to provide tablets to students studying in government colleges run under the Higher Education Department, based on the number of students available on M.I.S. in relation to the amount sanctioned under other departmental expenditure heads. Allocation of ₹ 1,18,54,68,000/- (₹ One Billion Eighteen Crore Fifty Four Lakh Eighty Thousand Only) for 105 Government Colleges for the Account Head 2245-80-800-02-Covid Disaster Assistance Scheme as follows in the college wise withdrawal distribution code. As per the instructions of Additional Chief Secretary Finance, Uttarakhand Government, the budget allocation has been done on the software available through internet.

Necessary instructions for the use of the funds being allocated

The sanctioned amount will be spent only on the item for which the amount is being sanctioned. Diversion of the sanctioned amount will not be accepted under any circumstances. Unauthorized expenditure should not be incurred in anticipation of additional grant and a bill for payment will also be presented in the treasury, in which along with the grant number the account title should also be clearly mentioned.

Subject: Providing tablets to students studying in government colleges for reimbursement of Hon'ble Chief Minister's Announcement No. 423/2

Regarding the above mentioned matter, Honorable Chief Minister's Announcement No. 423/2021 "Tablets will be provided to the students of Government Degree Colleges, I have to say that tablets will be made available to about 1.06 lakh students currently studying in Government Colleges under the Higher Education Department. To provide an amount of ₹ 12,000/- per student in their account through DDT, a total amount of ₹ 128.00 crore (Rs. 1 billion 60 crore only) will be spent as per the rules under the following conditions and restrictions for the current financial year 2021-22. Shri Governor gladly approves the implementation of:

- 1. The balance being sanctioned will be kept at disposal of the concerned drawing and distribution officers as per the rules and will be spent on the same item for which it is being sanctioned. Any diversion of sanctioned amount will not be accepted under any circumstances.
- 2. The said amount is being decided on the basis of the estimated number of students studying in colleges till the date of issue of the government order. Any variation in the actual number of students will be immediately informed to the government and in case the number of students is less, the remaining amount will be dedicated at the end of the financial year as per the rules. 3. In view of transparency in the distribution of tablets, each district will be headed by the District Magistrate.

A committee will be formed, in which the departmental nodal officer of the concerned district, A. Principals and PTA presidents of the concerned college/college will participate.

- 4. It will be the responsibility of the said committee to continuously monitor the progress of the scheme. Under which, to ensure the quality of the tablets purchased, it will be mandatory for the student to obtain the tablet purchase voucher within the stipulated period. 0. Regarding
- 5. The amount of money being sanctioned under the scheme will be given to the students selected/recommended by the said committee Will be transferred to bank accounts through DBT.

6. Details of the students who have availed the scheme at the college level will be maintained, which will be made available to the Directorate at the end of the academic session and will also be uploaded on the departmental website.

7. You can read the detailed guidelines on the departmental website.

8. By Students will purchase the latest model of Tablet, For this basically Specification). According to the guidelines dated 27.08.2021 issued by the Ministry of Electronics and Information Technology (Meity), the main ones are as follows: inch or more (TFT Captive, multi touch), operating system Android 10 or equivalent, processor Chad core (processor speed 1.8 GHz or more), RAM-2 48 or more, internal memory-32 GB or more, W-Bluetooth, Connectivity 4G/LTE- voice 36/20, Protective glass, Cover Case etc.

9. It is mandatory for the students to complete the Tablet sequence containing the specifications indicated in the supposition. Whichever is less between the purchase price and the amount collected as ₹ 12,000/-, will be acceptable.

2 This expenditure will be included in the the current financial year 2020-21 under grant number 07 under standard item 42-other departmental expenditure of account heading 2245-80-800-02.

National Scholarship Manual of OBC/SC/ST

Under the online scholarship scheme for Scheduled Caste, Scheduled Tribe and Other Backward Caste students, scholarship is provided to the students studying as per the following standards -

Eligibility for Scholarship Application:

- The student who is a native/permanent resident of Uttarakhand state should be studying as an institutional student in a recognized school/university/technical/medical/management institute running in the state or outside the state.
- The student must have passed the previous year's examination.
- The student should not be studying in more than one institution in the same academic year.
- Family annual income from all sources of parents and guardians of Scheduled Caste/Scheduled Tribe students is Rs. 2.50,000/- (Rupees two lakh fifty thousand only), parents and guardians of Other Backward Caste students Annual family income from all sources is Rs 1,50,000/- (Rupees one lakh fifty thousand only)
- Students applying for scholarship should select the correct institute in which they are studying while filling the online application form.
- If the information filled in the application form submitted by the students studying in the universities/institutions located in the state or outside the state is as per the prescribed standards, then the concerned institution will submit the online application form for the scholarship of the student from its level to the District Social Welfare Officer of the concerned district. Will be sent to the person, of which the four/four are original/permanent residents of the district.
- In case of scholarship and eligibility, there is a provision to transfer the amount of scholarship and fee online to the CBSE account of a nationalized bank operated in the name of the concerned student by the coordinated District Social Welfare Officer.
- This scholarship is provided under the rules prescribed by the Government of India/State Government.
- Under the Scheduled Caste/Tribe Post 10th Scholarship Scheme, scholarship is first paid to
 the students studying in government and aided schools. While giving priority to nongovernment vocational minority educational institutions, the payment of scholarship to the
 students of non-government schools and those students studying in vocational educational

institutions whose state is under state management quota was ensured, starting with the poorest of the poor on the basis of availability of funds. goes. Scholarship/fees is awarded to the eligible students studying in the state of Uttar Pradesh in the same place as per the address of the city.

- On this basis, payment of scholarship to the students studying in other states of Uttarakhand is
 ensured.
- Other Backward Class is Post 10th Scholarship Fund Limited Scheme, hence under this scheme, only such students studying in courses of Uttarakhand Technical Education Council, ETCNICM/ETCIA etc. Students who have been admitted through counseling and not those who have been admitted through management quota will be benefited.
